The Borough Council of Calderdale in exercise of its powers under Sections 1 and 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order to vary The Borough Council of Calderdale (School Entrance Clearway) Consolidation Order 2020.

1. This Order may be cited as The Borough Council of Calderdale (School Entrance Clearway) Consolidation Order 2020 (Variation No.*) Order 20** (hereinafter referred to as the "Variation Order" is made this xx day of xxxxx 20xx and will come into effect on xx xxxxx 20xx.
2. The Borough Council of Calderdale (School Entrance Clearway) Consolidation Order 2020 (hereinafter referred to as "the Consolidated Order") shall be varied as follows:-
 - i. The Items in Table A to this Variation Order are added to Schedule 1 of the Consolidation Order.
 - ii. Table B to this Variation Order is the Schedule of Revocations to the Consolidation Order and the orders listed in Column 1 of that Table are to be revoked to the extent laid down in Column 2.
3. Except as hereinbefore provided in this Variation Order the provisions and articles of the Consolidation Order shall remain in force.
4. The provisions imposed by this Variation Order are in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
