**NOTICE** is hereby given that the Borough Council of Calderdale ('the Council') in exercise of its powers under the Road Traffic Regulation Act 1984 proposes to make the above orders concerning roads in the Sowerby Bridge area, the effects of which will be:

New "No Waiting and No Loading at Any Time" restrictions on lengths of Oldham Rd (Rishworth).

New "No Waiting at Any Time" restrictions on lengths of Woodlands, Rochdale Rd (Triangle and Pye Nest), Lower Brockwell Ln, East St (Triangle), Burnley Rd (Luddenden Foot), Cooperfields (Luddenden Foot), Oldham Rd (Rishworth and Ripponden), Hollins Ln, Gratrix Ln, Bolton Brow, Pye Nest Rd, Pye Nest Ave, Arlington Cres, Crestfield Dr, Dorchester Dr, Park Rd, Willow Hall Ln, Willowfield Dr, Woodland Dr, Willow Dene Ave and the Tuel Ln Car Park access road.

New "No Waiting at Any Time and No Loading Mon to Fri 7.00am – 9.30am & 4.00pm-6.30pm" restrictions on lengths of Wharf St, Tuel Ln and the Tuel Ln car park access road.

New "Limited Waiting 30mins Mon to Sat 8.00am – 6.00pm no return within 1 hr" restriction on a length of Bolton Brow.

New "Disabled Parking 4 hrs return within 1 hr Mon – Sat 8am – 6pm" parking place and "Limited Loading 30 Minutes No Return within 1 hr (including Bank Holidays)" restrictions on lengths of Wharf St. Removal of existing "Disabled Parking 4 hrs no return within 1 hr Mon – Sat 8am – 6pm" parking place from Wharf St.

Reduced existing "School Keep Clear Markings" on Oldham Rd (Rishworth) at Rishworth School entrance. Removal of other such markings from that road at the Rishworth School exit and also from Burnley Rd at Luddenden Foot Academy.

The above proposals will also entail changes to, or in some cases the removal of, various existing waiting and loading restrictions on lengths of Burnley Rd, Oldham Rd (Ripponden), Wharf St and Tuel Ln.

Documents giving more detailed particulars of the orders, including the statement of reasons for them and plans showing the affected roads, are available for inspection at Halifax Central Library, Halifax, HX1 1QG, from 10.00 am to 5.30 pm on Mondays to Fridays and 10 am to 4.30 pm on Saturdays. If you wish to object to or make a representation to any part of the proposed orders, you must send the grounds for your objection or support in writing to reach the Council by not later than 6<sup>th</sup> October 2022 to either [CIP@calderdale.gov.uk](mailto:CIP@calderdale.gov.uk) or to Highways and Transportation, C/O the Town Hall, Crossley Street, Halifax, HX1 1UJ for the attention of the Highways Traffic Team. All objections must specify the grounds on which they are made.
