The Borough Council of Calderdale in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order (hereinafter referred to as "the Variation Order") to vary the Borough Council of Calderdale (Hebden Bridge Central Area) (Controlled Parking Zone) (Consolidation) Order 2008.

1. This Variation Order is made the xx day of xxxx 20xx and may be cited as "the Borough Council of Calderdale (Hebden Bridge Central Area) (Controlled Parking Zone) (Consolidation) Order 2008 (Variation No. \*) Order 20\*\*" and will come into operation on [TBC].
2. The Borough Council of Calderdale (Hebden Bridge Central Area) (Controlled Parking Zone) (Consolidation) Order 2008 (hereinafter referred to as "the Consolidation Order") shall be varied as follows:-
  - i. The items in Table A to this Variation Order are revoked from the Consolidation Order to the extent set out in Column 2 of that Table.
3. Except as hereinbefore provided in this Variation Order the provisions and articles of the Consolidation Order shall remain in force.
4. The provisions imposed by this Variation Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
