CONSOLIDATION ORDER 2020 (VARIATION NO. 1) ORDER 2023

NOTICE is hereby given that on 24 May 2023 the Borough Council of Calderdale ('the Council') in exercise of its powers under the Road Traffic Regulation Act 1984 made the above Orders concerning roads in the Sowerby Bridge area.

1. The Borough Council of Calderdale (Waiting and Loading and Parking Places) (Sowerby Bridge) (Consolidation) Order 2008 (Variation No. 1) Order 2023 was made in part ("Part A"), the effects of which are:

- New "No Waiting and No Loading at Any Time" restrictions on lengths of Oldham Rd (Rishworth).
- New "No Waiting at Any Time" restrictions on lengths of Woodlands, Rochdale Rd (Triangle and Pye Nest), Lower Brockwell Ln, East St (Triangle), Burnley Rd (Luddenden Foot), Cooperfields (Luddenden Foot), Oldham Rd (Rishworth and Ripponden), Hollins Ln, Park Rd, Willow Hall Ln, Willowfield Dr, Woodland Dr, and Willow Dene Ave.
- New "No Waiting at Any Time and No Loading Mon to Fri 7.00am – 9.30am & 4.00pm-6.30pm" restrictions on lengths of Tuel Ln and the Tuel Ln Car Park access road.
- Changes to, or in some cases the removal of, various existing waiting and loading restrictions on lengths of Oldham Rd (Ripponden) and Tuel Ln.

The Council has abandoned parts of the Order proposing new "No Waiting at Any Time" restrictions on lengths of Pye Nest Rd, Pye Nest Ave, Arlington Cres, Crestfield Dr, Dorchester Dr, Rochdale Rd (Pye Nest), and the Tuel Ln Car Park access road.

The Council defers making the remainder of the Order until a later date. The outstanding proposals are:

- New "No Waiting at Any Time" restrictions on lengths of Gratrix Ln and Bolton Brow;
- New "Limited Waiting 30mins Mon to Sat 8.00am – 6.00pm no return within 1 hr" restriction on a length of Bolton Brow;
- New "Disabled Parking 4 hrs return within 1 hr Mon – Sat 8am – 6pm" parking place and "Limited Loading 30 Minutes No Return within 1 hr (including Bank Holidays)" restrictions on lengths of Wharf St. Removal of existing "Disabled Parking 4 hrs no return within 1 hr Mon – Sat 8am – 6pm" parking place from Wharf St;
- New "No Waiting at Any Time and No Loading Mon to Fri 7.00am – 9.30am & 4.00pm-6.30pm" restrictions on a length of Wharf St; and
- Removal of various existing waiting and loading restrictions on lengths of Burnley Rd and Wharf St.

2. The Borough Council of Calderdale (School Entrance Clearway) Consolidation Order 2020 (Variation No. 1) Order 2023 was made in full. Its effects are to reduce existing "School Keep Clear Markings" on Oldham Rd (Rishworth) at Rishworth School entrance, remove other such markings from that road at the Rishworth School exit and also from Burnley Rd at Luddenden Foot Academy.

Both Orders will come into force on 5th June 2023

If you wish to question the validity of the Orders or of any of their provisions on the ground that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date on which the relevant Order was made, apply to the High Court for this purpose.
