


Figure 75 Northowram & Shelf Broad Area

The vast majority of land parcels in the Northowram and Shelf Broad Area perform well when assessed against Green Belt purposes with only 4 land parcels not being classified as highly sensitive. These parcels are Land between Green Lane and Carr House Road (037-00), Land south of Lands Head Lane (195-00), Land south east of Soaper Lane (196-00) and Land at Lumbrook Mills (440-00). A number of these parcels already contain extensive existing development with the remainder being inlier parcels that are surrounded by the urban area on three or more sides. These parcels satisfy only two or less of the purposes for Green Belt designation.

Excluding purpose IV; Preserving the setting and special character of historic towns (only a small number of land parcels are located in close proximity to a conservation area, listed building, historic park or garden or other features of historic significance) and purpose V (all Green Belt parcels were deemed to satisfy this purpose), the purposes for designating Green Belt all perform similarly in the Northowram and Shelf Broad Area. This is because many of these parcels have high potential for sprawl, prevent neighbouring towns from merging and perform an important role in safeguarding the countryside from encroachment.






