The Borough Council of Calderdale in exercise of its powers under Sections 84(1) and 84(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

1. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in the First Schedule to this Order.
2. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of road specified in the Second Schedule to this Order.
3. The orders listed in Column 1 of the Third Schedule to this Order are revoked to the extent listed in Column 2 of the said Schedule.
4. No speed limit imposed by this Order applies to vehicles falling with regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendments) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
5. This Order is made this xx day of xxxx 20xx and shall come into operation on the 22nd day of May 2023 and may be cited as "The Borough Council Of Calderdale (Speed Limit) (B6114 Saddleworth Road, Barkisland) Order 20**".
