# THE BOROUGH COUNCIL OF CALDERDALE (STAFFORD ROAD) (HALIFAX) EXPERIMENTAL TRAFFIC REGULATION ORDER 2023

The Borough Council of Calderdale in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 (the "Act") and of all other enabling powers and after consultation with the Chief of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

### PART 1 GENERAL

#### Citation and commencement

- 1. This Order is made on the 6<sup>th</sup> day of September 2023 and shall come into operation on 14<sup>th</sup> September 2023 and shall be cited as "The Borough Council of Calderdale (Stafford Road) (Halifax) Experimental Traffic Regulation Order 2023".
- 2. This Order is made on an experimental basis and will remain in force for a maximum period of eighteen months.

#### Interpretation

- 3. The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.
- 4. Where a provision of this Order is in conflict with a provision contained in a previous order, the provisions of this Order shall prevail for the period that this Order is in force.
- 5. Where a statute, statutory instrument, specification or regulation is referred to such reference shall include an amendment to or replacement thereof.
- 6. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction, regulation or other requirement imposed by law.
- 7. For the avoidance of doubt any reference in this Order to a length of road shall be deemed to be a reference to more than one length of road where the context requires it. The lengths of roads specified in the Schedules to this Order are shown for illustrative purposes only on drawing number:- 72/1348/103 annexed hereto.

#### **Definitions**

- 8. In this Order, the following expressions have the meaning hereby respectively assigned to them:-
  - "Council" means the Borough Council of Calderdale and includes any contractors or authorised agents appointed by or acting on behalf of the Council for the purposes of any function under the provisions of this Order;

"Motor Vehicle" has the same meaning as that in Section 136 of the Road Traffic Regulation Act 1984;

"Road" has the same meaning as that in Section 142 of the Road Traffic Regulation Act 1984:

"Undertaker" has the same meaning as that in Section 48 of the New Roads and Street Works Act 1991;

"Vehicle" has the same meaning as that in Section 136 of the Road Traffic Regulation Act 1984.

# PART 2 PROHIBITION OF DRIVING

9. Save as provided in Article 10, no person shall except upon the direction or with the permission of a police constable in uniform cause or permit any Motor Vehicle to proceed in the length of Road specified in the Schedule to this Order at any time

## PART 3 MODIFICATIONS

- 10. This Order includes provision for the Council's Assistant Director, Strategic Infrastructure, or person authorised by the aforementioned officer, to modify or suspend this Order or any provision of it if it appears to him essential:
  - a) in the interests of the expeditious, convenient and safe movement of traffic,
  - b) in the interests of providing suitable and adequate on-street parking facilities, or
  - c) for preserving or improving the amenities of the area through which any road affected by this Order runs.
- 11. The power in Article 11 shall not include making additions to the Order and shall be exercised only after consulting the appropriate chief officer of police and giving such notice as the Secretary of State may direct.
